- The above results have been reviewed by the Audit Committee and approved by the Board of Directors of the Company in their meetings held on 21st May, 2026
- During the financial year 2018-19 the Government of Andhra Pradesh (GOAP) vide its notification for compulsory acquisition has acquired buildings, trees and other structures belonging to the company under Section 4(1) of the Land Acquisition Act, 1894 for establishing Petroleum, Chemical and Petrochemical Investment Region (PCPIR) Corridor and paid the compensation for the same in the month of April 2018. However the possession of the land, buildings acquired is not yet taken by the (GOAP). It has informed the company that it will give a prior intimation before taking the possession of the same. Thus these areas have been given on lease after informing the lessees that they have to evacuate the place when GOAP takes the possession of the same.
- The figures for the quarter ended March 31, 2026 and March 31, 2025 are the balancing figures between the audited figures of the full financial year ended March 31, 2026 and March 31, 2025 respectively and the published year to date figures upto the nine months ended December 31, 2025 and December 31, 2024 respectively.
- The Exceptional Item pertains to profit on sale of Land of Rs 253.36 Lakhs for the Quarter ended 31st December 2025, of Rs.299.67 Lakhs for the year ended 31st March 2026 and Rs.434.74 Lakhs for the year ended 31st March 2025

Independent Auditor's Report on the Annual Financial Results pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosures Requirements) regulations, 2015

Opinion

We have audited the accompanying annual financial results of **NCC Blue Water Products Limited** (hereinafter referred to as the "Company") for the year ended 31st March 2026 ("annual financial results"), being submitted by the Company pursuant to the requirement of Regulation 33 of the Securities and Exchange Board of India ("Listing Obligations and Disclosure Requirements") Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us the aforesaid annual financial results:

The financial statements have been prepared on a going concern basis considering the circumstances stated in Note no. 2 to the financial results pending crystallization of Company's plans for revamping its operations.

Our opinion is not modified in respect of the above matter.

These annual financial results have been prepared on the basis of the annual financial statements.

The Management and the Board of Directors are responsible for the preparation and presentation of these annual financial results that give a true and fair view of the net profit and other comprehensive income and other financial information in accordance with the recognition and measurement principles laid down in Indian Accounting Standards prescribed under Section 133 of the Act and other accounting principles generally accepted in India and compliance with Regulation 33 of the Listing Regulations. The Management and Board of Directors of the company are responsible for maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies ; making judgments and estimates that are reasonable and prudent ; and the design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring accuracy and completeness of the accounting records, relevant to the preparation and presentation of the annual financial results that give a true and fair view and are free from material misstatement , whether due to fraud or error.
